PROCEDURAL ORDER

BY THE COMMISSION:

In Decision No. 62754 (July 25, 2000), the Arizona Corporation Commission (“Commission”) approved the application of Arizona Water Company (“Arizona Water”) for a Certificate of Convenience and Necessity (“Certificate”) to provide water service to a development of approximately 6,000 residential lots located near Oracle Junction in Pinal County, Arizona. The Decision ordered Arizona Water to file a copy of the developer’s Certificate of Assured Water Supply within five years of the effective date of the Decision.

On May 6, 2005, Arizona Water filed a request for additional time to comply with the requirement to file the Certificate of Assured Water Supply. Arizona Water reports that Robson Communities, the developer, has experienced unexpected delays in planning and financing the development and will not be ready to proceed with development until 2006. Arizona Water requests an additional 365 days from the fifth year anniversary of the Decision, until July 25m 2006, to file the developer’s Certificate of Assured Water Supply for the area at issue.

On November 14, 2005, Commission Utilities Division Staff (“Staff”) filed its Memorandum which indicates that Staff has no objection to the requested extension.

The requested extension will not prejudice any other party, as Arizona Water was the only entity for the subject area.




