PROCEDURAL ORDER

BY THE COMMISSION:

On July 7, 2005, Perkins Mountain Utility Company filed with the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide potable wastewater to a master-planned community in Mohave County, Arizona. On that same date, Perkins Mountain Water Company filed an application with the Commission for a Certificate to provide water to a master-planned community in Mohave County, Arizona.

On September 27, 1005, Sports Entertainment, LLC filed an Application to Intervene. There has been no opposition to the Application to Intervene.

IT IS THEREFORE ORDERED that Sports Entertainment, LLC is granted intervention.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized Communications) applies to this proceeding as the matter is now set for public hearing.


