PROCEDURAL ORDER

BY THE COMMISSION:

On December 9, 2005, the Arizona Corporation Commission ("Commission") issued Decision No. 68323 in the above-captioned matter. Decision No. 68323 ordered that a Notice of Proposed Rulemaking to address changes to Commission Rule R14-3-113 ("Rule 113")<sup>1</sup> and to adopt proposed Rule R14-3-220 be forwarded to the Arizona Secretary of State for publication in the Arizona Administrative Register.

Decision No. 68323 further ordered that a public comment hearing be scheduled. Accordingly, a public comment hearing should be scheduled on the Proposed Rulemaking.

IT IS THEREFORE ORDERED that in accordance with the requirements of A.R.S. §§ 41-1022(D) and 41-1023(D), a **public comment hearing** on the proposed amendment of A.A.C. R14-3-113 shall be held on **February 16, 2006, at 1:30 p.m.**, at the Commission's offices located at 1200 West Washington, Phoenix, Arizona.

IT IS FURTHER ORDERED that the Utilities Division shall cause timely notice of the proposed rulemaking, including the public comment hearing date and location set forth above, to be published in the Arizona Administrative Register in accordance with A.R.S. §§ 41-1022(D) and 41-1023(D).

IT IS FURTHER ORDERED that comments on the proposed amendment of A.A.C. R14-3-113 and proposed Rule R14-3-220 will be taken into the record of this proceeding through February

2 IT IS FURTHER ORDERED that in order to allow the filing of responsive written comments  
3 in this docket prior to the date of the public comment hearing, companies or other interested persons  
4 and entities should file their initial written comments on the proposed rules in this docket on or before  
5 January 19, 2006.

6 IT IS FURTHER ORDERED that companies or other interested persons and entities, and the  
7 Commission's Utilities Division, are directed to file written comments in response to the initial  
8 written comments on or before February 9, 2006.

9 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive  
10 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
