Dear Linda:

Upon review of your July 29, 2005 Memorandum to Docket Control which we just received, it was determined that the legal description for the Requests for Service from property owners in Section 14 were inadvertently omitted from my July 26 letter to you. Those parcels were included in my response to Judge Stern's Staff (dated July 6, not July 8 as I indicated in my July 26 correspondence to you). However, those parcels were not included in my July 26 letter exhibit that you appended to your July 29 Memorandum.

Attached is a revised exhibit showing four additional parcels owned by two property owners totaling 180 acres. Please note Letter No. 6 to my July 6 exhibit shows 160 acres in Section 14.
