I.

Pursuant to Rule R14-3-105, the ARIZONA UTILITY INVESTORS ASSOCIATION, INC. (AUIA) hereby applies to the Arizona Corporation Commission (Commission) for an order granting it leave to intervene in the above-captioned proceeding.

II.

AUIA represents the interests of investors in electric, gas, water and telecommunications companies which are based in or are authorized to do business in the state of Arizona.

III.

AUIA's membership includes approximately six thousand individuals, many of whom own the common stock of Pinnacle West Capital Corporation, the holding company for Arizona Public Service Company.

IV.

The cash flows and profitability of Pinnacle West and the value of debt and equity investments therein may be directly and materially affected by any order of the Commission in this matter.

V.

In order to represent the interests of Pinnacle West shareholders, AUIA must be able to examine thoroughly any materials submitted as evidence in this proceeding and to offer appropriate testimony.

VI.

Granting AUIA intervenor status will not unduly broaden the issues in this proceeding.




