8 **BY THE COMMISSION:**

9 On October 18, 2001, the Arizona Public Service Company ("APS") filed a Request for a
10 Partial Variance to A.A.C. R14-2-1606(B) and for Approval of a Purchase Power Agreement.

11 A Procedural Conference was held on December 5, 2001, to discuss procedural issues and the
12 appropriate scope of this proceeding. APS filed direct testimony on December 12, 2001, and the
13 parties filed briefs on December 19, 2001. Accordingly, a Procedural Conference should be held to
14 further discuss the procedural posture and schedule in this matter.

15 IT IS THEREFORE ORDERED that a Procedural Conference will be held on January 31,
16 2002, at 1:30 p.m. or as soon thereafter as is practical, at the Commission offices, 1200 West
17 Washington Street, Phoenix, Arizona.

18 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
19 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing
