I, Curtis L. Kebler, upon first being duly sworn upon my oath do say:

1. I am the same Curtis L. Kebler who has previously testified in the matter of generic proceedings concerning electric restructuring issues, et al., in Arizona Corporation Commission Docket No. E-00000A-02-0051.

2. The purpose of this Affidavit is to expand on and clarify my answer to Mr. Kempsey, legal counsel for the Arizona Corporation Commission at pages 854 and 855, Volume III of the June 19, 2002 transcript in the above referenced proceeding on Track A Issues.


3. In particular, Reliant Energy Services, Inc. and Reliant Energy Power Generation, Inc. ("Reliant") filed a response on May 31, 2002 in FERC Docket No. PA02-2-000 admitting that it made one volume boosting roundtrip trade in the WSCC at Palo Verde in Arizona during the period 2000-2001, and described various same-day, non-roundtrip transactions. This initial response was unilaterally supplemented by Reliant on June 11, 2002 to provide transaction information and documentation relating to two 1999 roundtrip electricity transactions of the same type falling outside of the timeframe set forth in the FERC data request. Reliant's unilateral supplement also provided transaction information relative to the same-day, non-roundtrip transactions described in the original response.

4. In its original May 22, 2002 responses to FERC in Docket No. PA02-2-000, Reliant also discussed certain of its activities and transactions in the California market in response to certain FERC data requests regarding trading activities described in memoranda released by Enron Power Marketing Inc.. Reliant explained how its activities a) were differentiated from those described in the Enron memoranda; and b) generally benefited the California market and California's customers by

improving system-wide efficiency and reducing the volatility of post congestion prices and/or increasing supply and reducing real time energy prices.
