12 FINDINGS OF FACT

- 13 1. Arizona Public Service ("APS") is certificated to provide electric service as a public
- 14 service corporations in the State of Arizona.
- 15 2. On March 22, 2001, APS filed an application to introduce a new tariff for Commission
- 16 approval. The tariff is identified as Station Use Service tariff (Schedule E-36). The proposed tariff,
- 17 would apply to large (3 MW or greater) generating facilities requiring start-up and auxiliary power.
- 18 3. Staff has recommended that the application be suspended for sixty (60) days so that
- 19 Staff can have sufficient time to evaluate the application.

20 CONCLUSIONS OF LAW

- 21 1. APS is an Arizona public service corporations within the meaning of Article XV,
- 22 Section 2, of the Arizona Constitution.
- 23 2. The Commission has jurisdiction over APS and over the subject matter of the
- 24 application.
- 25 3. The Commission, having reviewed the application and Staff's Memorandum dated
- 26 March 30, 2001, concludes that it is in the public interest to suspend the application for a period of
- 27 sixty (60) days.



ORDER


THEREFORE, IT IS ORDERED that the application be and hereby is suspended until and including June 20, 2001.


