17 On September 26, 2005, Administrative Law Judge ("ALJ") Amy B. Bjelland issued a  
 18 procedural order in the above captioned proceeding. ALJ Bjelland ordered the Utilities Division  
 19 Staff of the Arizona Corporation Commission ("Staff") to file a Staff Report by November 10,  
 20 2005. Staff respectfully requests an extension of time to file the Staff Report by November 17,  
 21 2005.

22 Staff contacted Applicant Arizona Water Company (the "Company") and the Company  
 23 agreed to an extension with a condition that its response be similarly extended. The procedural  
 24 order included a response date of November 25, 2005. The Company indicated that a response  
 25 date of December 1, 2005 was acceptable.

26 Staff also contacted the City of Eloy. The City of Eloy filed an application to intervene  
 27 on November 2, 2005. The City did not object to the request for an extension.


