



11 **BY THE COMMISSION:**

12 Having considered the entire record herein and being fully advised in the premises, the
13 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

14 **FINDINGS OF FACT**

15 1. CallManage, Inc. has a Certificate of Convenience and Necessity ("Certificate") to
16 provide competitive resold interexchange telecommunications services in the State of Arizona
17 pursuant to Decision No. 62882 (September 18, 2000).

18 2. On June 14, 2001, CallManage, Inc. filed with Docket Control of the Commission an
19 application requesting cancellation of the Certificate.

20 3. CallManage, Inc. states in its request that it has limited the scope of its operations and
21 has decided against providing telecommunications services within the State of Arizona.

22 4. CallManage, Inc. has not served any Arizona customers and therefore, no
23 prepayments, advances, or deposits are at risk by the cancellation of the Certificate.

24 5. On July 3, 2001, the Commission's Utilities Division Staff ("Staff") filed a Response
25 recommending approval of CallManage, Inc.'s application for cancellation of its Certificate of
26 Convenience and Necessity without a hearing.

27 6. Pursuant to Commission rules, the Commission may grant the application without a
28 hearing.

CONCLUSIONS OF LAW

1
2 1. CallManage, Inc. is a public service corporation within the meaning of Article XV of
3 the Arizona Constitution and A.R.S. §§ 40-281 and 40-282.

4 2. The Commission has jurisdiction over CallManage, Inc. and the subject matter of the
5 application.

6 3. The cancellation of CallManage, Inc.'s Certificate is in the public interest.

7 4. The cancellation of CallManage, Inc.'s Certificate is reasonable and should be
8 adopted.

ORDER

9
10 IT IS THEREFORE ORDERED that the application of CallManage, Inc. for the cancellation
11 of its Certificate of Convenience and Necessity to provide competitive resold interexchange
12 telecommunications services shall be, and the same is hereby approved.

13 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
