NOTICE OF APPLICATION FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE RESOLD INTRA-EXCHANGE TOLL TELECOMMUNICATIONS SERVICES BY TALK.COM D/B/A THE PHONE COMPANY D/B/A NETWORK SERVICES OF NEW HOPE

Talk.com d/b/a The Phone Company d/b/a Network Services of New Hope has filed with the Arizona Corporation Commission an application for a Certificate of Convenience and Necessity to provide resold intrastate toll telecommunications services in the State of Arizona. Applicant will be required by the Commission to provide this service under the rates and charges and terms and conditions established by the Commission.

A.R.S. § 40-282 provides that the Commission may act on an application for a Certificate to provide resold telecommunications services without a hearing, or with a hearing, if one is requested by any party, applicant or any other party must request a hearing by September 7, 2001, or the commission will rule on the application without a hearing.

The applications report of the Commission's Utilities Division Staff, and any written exceptions to the staff report prepared by the applicant are available for inspection during regular business hours at the offices of the Commission located at 1200 West Washington Street, Phoenix, Arizona 85007, and at the applicant's address, 6805 Route 202, New Hope, PA 18938.

Under appropriate circumstances, interested parties may intervene in the proceedings and participate as a party. Intervention shall be in accordance with A.A.C. R14-3-105, except that all motions to intervene must be filed on or before June 28, 2001. You may have the right to intervene in the proceeding, or you may make a statement for the record. 


