13 FINDINGS OF FACT

14 1. Sprint Communications Company ("Sprint") is certified to provide intrastate
15 telecommunications service as a public service corporation in the State of Arizona.

16 2. On December 15, 2000, Sprint filed tariff revisions to its Arizona Tariff No. 2:

24 3. This filing introduces an "In-State Access Recovery Charge." This filing would result
25 in a flat monthly charge on all of Sprint's Arizona Dial 1 accounts (i.e., Sprint's Arizona long distance
26 customers). Sprint is proposing a maximum rate of \$5.00 on this new charge. Sprint is proposing an
27 initial actual rate of \$1.98.

28 4. Since this filing increases the maximum rates for a component of a service that has been
classified as competitive under the Commission's Competitive Telecommunications Services Rules,
A.A.C. Rule R14-2-1110 applies to Sprint's proposal.




IT IS THEREFORE ORDERED that the filing be and hereby is denied.
