PROCEDURAL ORDER

BY THE COMMISSION:

On October 2, 2001, in Decision No. 64068 the Arizona Corporation Commission ("Commission") approved the application of Gates Communications, Inc. ("Company") for a Certificate of Convenience and Necessity ("Certificate") to provide competitive resold interexchange telecommunication services, except local exchange services. The Company was ordered to file, no later than 18 months from the effective date of the Decision (April 2, 2003), the Company's Fair Value information.

On May 12, 2003, the Company filed with the Commission an application requesting an extension of a filing date established in Decision No. 64068 due to confusion whether the information had been filed. The Company's application contained an attachment dated November 15, 2001, which had been filed earlier containing the Company's Fair Value information..


On May 21, 2002, the Commission's Utilities Division ("Staff") filed its response. Staff recommended that this request should be approved and that the filing of May 12, 2003 confirmed that the required filing had been made with the Commission.

Under the circumstances, the Company's request for an extension of time is reasonable.
