PROCEDURAL ORDER

BY THE COMMISSION:

On May 10, 2001 Lago Del Oro Water Company ("Lago" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for an extension of its Certificate of Convenience and Necessity ("CC&N") to provide water service to a proposed 770 residential units approximately 25 miles north of Tucson in Pinal County, Arizona, in a development known as SaddleBrooke.

On May 23, 2001, the Commission's Utilities Division Staff ("Staff") filed a Sufficiency Letter indicating that Lago has met the sufficiency requirements as set forth in A.A.C. R14-2-402(C) and R14-2-602(A)(2).

Pursuant to A.A.C. R14-3-101, the Commission now issues this Procedural Order to govern the preparation and conduct of this proceeding.

IT IS THEREFORE ORDERED that the hearing in the above-captioned matter shall commence on **August 1, 2001, at 9:00 a.m.** or as soon thereafter as is practical, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona 85007.

IT IS FURTHER ORDERED that intervention shall be in accordance with A.A.C. R14-3-105, except that all motions to intervene must be filed on or before July 18, 2001.

IT IS FURTHER ORDERED that objections to any motions to intervene must be filed by **12 noon** on July 25, 2001.

IT IS FURTHER ORDERED that the Company shall provide public notice of the hearing in this matter, in the following form and style:

1 IT IS FURTHER ORDERED that the Company shall file certification of mailing as soon as
2 practicable after the mailing has been completed but not later than July 18, 2001.

3 IT IS FURTHER ORDERED that notice shall be deemed complete upon mailing of same,
4 notwithstanding the failure of an individual customer to read or receive the notice.

5 IT IS FURTHER ORDERED that the time periods specified herein shall not be extended
6 pursuant to Rule 6(a) or (e) of the Rules of Civil Procedure.

7 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
8 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


