PROCEDURAL ORDER 5

...

1 **BY THE COMMISSION:**

2 On January 29, 2001, the Securities Division ("Division") of the Arizona Corporation
3 Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to
4 Cease and Desist, for Restitution, for Administrative Penalties, and for Other Affirmative Action
5 ("Notice") against Mobile Cash Systems, LLC; World Wireless Solutions, Inc. a/k/a Wireless
6 Express USA, Inc.; World Electronic Payment Solutions, Inc. d/b/a WEPS; World Cash Providers,
7 LLC; World Cash Providers, Inc.; Mark Alan Melkowski, Sr.; Eagle Communications, Inc.; Eagle
8 One Financial & Tax, LLC; Gerald B. ("Jerry") Johnson; and Kimber Lea Baudour, (collectively the
9 "Respondents") in which the Division alleged that Respondents have engaged in acts, practices, and
10 transactions that constitute violations of the Arizona Securities Act ("Act").

11 On February 5, 2001, Respondents Mobile Cash Systems, LLC; World Wireless Solutions,
12 Inc., a/k/a Wireless Express USA Inc.; World Electronic Payment Solutions, Inc., d/b/a WEPS;
13 World Cash Providers, LLC; World Cash Providers, Inc. and Kimber Lea Baudour filed a request for
14 hearing.

15 On February 13, 2001, Respondents Mark Alan Melkowski, Sr., Eagle Communications, Inc.,
16 and Eagle One Financial and Tax, LLC, through counsel, filed a request for hearing.

17 On March 26, 2001, a pre-hearing conference was held addressing issues raised in the Notice.

18 On March 29, 2001, the Commission issued a procedural order setting the matter for hearing
19 on May 2, 2001.

20 On April 18, 2001, Respondent Mark Alan Melkowski, Sr. on behalf of himself and Eagle
21 Communications, Inc., and Eagle One Financial and Tax, LLC filed a request for a continuance of the
22 hearing.

23 On April 23, 2001, the Division filed its response agreeing with the continuance.

24 On April 24, 2001 a telephonic conference was held with all parties represented except Mr.
25 Johnson. During that conference all parties, again with the exception of Mr. Johnson, agreed to
26 continue the hearing until September.

27 On April 24, 2001, the Commission issued a procedural order that vacated the May 2, 2001
28 hearing and reset the matter until September 18, 2001.

1 On May 9, 2001, the Division and Mobile Cash Systems, World Wireless Solutions, Inc. a/k/a
2 Wireless Express USA, Inc., World Electronic Payment Solutions, Inc. d/b/a WEPS, World Cash
3 Providers, LLC, World Cash Providers Inc. and Kimber Lea Baudour entered into a consent order.

4 On May 22, 2001, the proposed consent order was brought before the Commission at an open
5 meeting for approval. The Commission approved the consent order.

6 On May 24, 2001, the Commission filed Decision No. 63680 which approved the settlement
7 between the Division and Mobile Cash Systems, World Wireless Solutions, Inc. a/k/a Wireless
8 Express USA, Inc., World Electronic Payment Solutions, Inc. d/b/a WEPS, World Cash Providers,
9 LLC, World Cash Providers Inc. and Kimber Lea Baudour.

10 On May 31, 2001, the Commission received a request for a hearing from Gerald Johnson. In
11 the request Mr. Johnson indicates he failed to request the hearing earlier because he was given false
12 information, although he does not indicate who gave him such information.

13 Accordingly, based Mr. Johnson's motion, the lack of any objection by the other parties and
14 good cause appearing, a pre-hearing should be set in this matter.

15 IT IS THEREFORE ORDERED that a pre-hearing regarding Mr. Johnson's motion shall be
16 set for June 18, 2001 at 10:30 a.m. at the Commission's offices, 1200 West Washington Street,
17 Phoenix, Arizona.

18 IT IS FURTHER ORDERED that, based on his family circumstances, Mr. Melkowski is not
19 required to attend the pre-hearing, however, he is entitled to do so if he chooses.

20 IT IS FURTHER ORDERED that the hearing scheduled September 18, 2001, at 9:00 a.m., at
21 the Commission's offices, 1200 West Washington Street, Phoenix, Arizona is affirmed.
