

PROCEDURAL ORDER

1 **BY THE COMMISSION:**

2 On January 29, 2001, the Securities Division ("Division") of the Arizona Corporation
3 Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to
4 Cease and Desist, for Restitution, for Administrative Penalties, and for Other Affirmative Action
5 ("Notice") against Mobile Cash Systems, LLC; World Wireless Solutions, Inc. aka Wireless Express
6 USA, Inc.; World Electronic Payment Solutions, Inc. dba WEPS; World Cash Providers, LLC; World
7 Cash Providers, Inc.; Mark Alan Melkowski, Sr.; Eagle Communications, Inc.; Eagle One Financial
8 & Tax, LLC; Gerald B. ("Jerry") Johnson; and Kimber Lea Baudour, (collectively the
9 "Respondents") in which the Division alleged that Respondents have engaged in acts, practices, and
10 transactions that constitute violations of the Arizona Securities Act ("Act").

11 On February 13, 2001, Respondents Mark Alan Melkowsi, Sr., Eagle Communications, Inc.,
12 and Eagle One Financial and Tax, LLC, through counsel, filed a request for hearing.

13 Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the
14 Notice and the presentation of evidence.

15 IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on March 26
16 2001, at 10:00 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.
