1 The Securities Division of the Arizona Corporation Commission hereby responds to the
2 Motion to Continue the hearing, filed by Respondents Mark Alan Melkowski, Sr., ("Melkowski"),
3 Eagle Communications, Inc. ("Eagle"), and Eagle One Financial & Tax, LLC ("Eagle One")
4 (hereafter collectively "Melkowski Respondents").

5 The Division does not object to the continuance of the hearing until the week of August 13,
6 2001, as requested by the Melkowski Respondents. The remaining Respondents in this matter,
7 except for Respondent Johnson, who did not request a hearing, have entered into a proposed
