PROCEDURAL ORDER

**BY THE COMMISSION:**

On April 24, 2001, Peter and Patricia Goshia dba Burro Inn ("complainant") filed a Complaint with the Arizona Corporation Commission ("Commission") against Citizens Communications Company ("Citizens"). On May 18, 2001, Citizens filed an Answer. By Procedural Order dated May 30, 2001, the Hearing Division set the matter for hearing on July 12, 2001.




