BY THE COMMISSION:

On November 14, 2005, the Securities Division ("Division") of the Arizona Corporation
 Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of
 Opportunity for Hearing ("Notice") against Bruce R. Goldman, Linda L. Goldman, Natasha Mull,

1 Opulent Properties, L.L.C. ("Opulent"), Mill Direct Flooring, L.L.C. ("MDF") and the Loan Xperts,
2 L.L.C. ("LX") (collectively "Respondents"), in which the Division alleged that the Respondents
3 individually and/or as members of or as managers of Opulent, MDF and LX committed multiple
4 violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in
5 the form of investment contracts. As a result of the T.O., the Respondents were immediately ordered
6 to cease and desist from violating the Act.

7 Respondents Bruce Goldman, Linda Goldman and Natasha Mull were duly served with copies
8 of the Notice.

9 On December 15, 2005, Respondents Linda Goldman and Natasha Mull filed responses to the
10 Division's action generally denying the allegations contained in the T.O. and Notice. Respondent
11 Bruce Goldman did not file a response or request a hearing.

12 Accordingly, the responses of Respondents Linda Goldman and Natasha Mull should be
13 treated as requests for a hearing and a pre-hearing conference should be held to address the issues
14 raised in the T.O. and the Notice along with the presentation of evidence.

15 IT IS THEREFORE ORDERED that a **pre-hearing conference** shall be held on **January 19,**
16 **2006, at 9:30 a.m.** at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.
