PROCEDURAL ORDER

BY THE COMMISSION:

On November 10, 2003, the Arizona Corporation Commission ("Commission") issued Decision No. 66510 which granted extensions of the Certificates of Convenience and Necessity to Midvale Telephone Exchange, Inc. ("Midvale").

On August 10, 2004, the Commission issued Decision No. 67156 which supplemented Decision No. 66510 and contained additional conditions.

On November 21, 2005, Midvale filed a request for an extension of time in which to comply with certain conditions contained in Decision No. 67156, specifically with respect to filing an update to its franchise with Yavapai County for the extension area and a certificate that Midvale has obtained all of the required tower and right-of-way permits.

IT IS THEREFORE ORDERED that Staff shall file, by no later than January 17, 2006, a Response to the Applicant's Motion for Extension of Time.


