PROCEDURAL ORDER

BY THE COMMISSION:

On December 9, 2004, Southwest Gas Corporation ("Southwest Gas") filed an application with the Arizona Corporation Commission ("Commission") for an increase in its rates throughout the State of Arizona.

Hearings commenced on October 3, 2005 and concluded on October 11, 2005. Post-Hearing Briefs and Reply Briefs were filed on November 4 and 14, 2005, respectively.


