On November 3, 2004, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist and Notice of opportunity for Hearing ("Notice") against WSK Energy LLC and Kevin H. Krause and Jane Doe Krause, husband and wife (collectively, "Respondents").

On November 24, 2005, Respondents, through their attorneys, filed a Notice of Appearance and Request for Hearing.

On September 13, 2005, by Procedural Order, the proceeding was scheduled for hearing on January 11, 2006.


The Division has finalized settlement negotiations with Respondents resulting in the execution of two proposed consent orders, one with respect to Respondent WSK Energy LLC and one with Respondent Krause ("Proposed Orders").

The Proposed Orders shall be presented by the Division and Respondents' Attorneys to the Commission for approval during the Open Meeting on February 2, 2006.
