The City of Scottsdale, pursuant to A.A.C. R14-3-105, hereby moves to intervene in the above-captioned proceeding. In support hereof, the City of Scottsdale states as follows:

The City of Scottsdale wishes to intervene in the matter of the Application of Arizona Public Service Company for a Hearing to Determine the Fair Value of the Utility Property of the Company for Ratemaking Purposes, to Fix a Just and Reasonable Rate of Return Thereon, to Approve Rate Schedules Designed to Develop Such Return, and to Amend Decision No. 67744. The City is a municipal customer of the Utility, many of its citizens are residential customers of the Utility, and all Scottsdale citizens help pay for City power costs. Therefore, the City has an interest in the matter both as a ratepayer and as a representative of its citizens.
