SCHEDULING
PROCEDURAL ORDER

14 **BY THE COMMISSION:**

15 On October 26, 2005, the RHI and Yucatan Respondents filed a Motion to Reset Hearings
16 (“Motion”) in the above-captioned matter from November 8, 9 and 10 and December 1 and 2, 2005,
17 due to scheduling conflicts of counsel for RHI and Yucatan. Counsel for Mr. Kelly had no objection
18 to the Motion. Respondents suggested that the proceeding be rescheduled for the weeks of January
19 23 and 30, 2006, and that neither counsel for Mr. Kelly nor the Division had a conflict with the
20 alternate dates.

21 On October 27, 2005, the Division filed a response which objected to the matter being
22 rescheduled.

23 On October 31, 2005, by Procedural Order, the proceeding was continued to resume on
24 January 23, 2006, with additional days of hearing scheduled on January 24, 25, 26, 27, 30, 31,
25 February 1, 2 and 3, 2006. Subsequently, the Commission scheduled its January 2006, Open Meeting
26 concerning utilities matters to commence on January 24, 2006 and if not concluded on that date, to be
27 continued to January 25, 2006.

28 Under the circumstances, the hearing in the above-captioned proceeding shall commence as
scheduled on January 23, 2006, as previously scheduled and be in recess on January 24, 2006. The
parties to this proceeding should contact the Hearing Division telephonically at (602) 542-4250 on
January 24, 2006, not later than 4:00 p.m. to verify that the proceeding will resume on January 25,
2006, or be continued to January 26, 2006.

1 IT IS THEREFORE ORDERED that the **hearing** shall recommence as scheduled previously
2 on **January 23, 2006, at 9:30 a.m.**, at the Commission's offices, 1200 West Washington Street,
3 Phoenix, Arizona.

4 IT IS FURTHER ORDERED that the proceeding shall be in recess January 24, 2006.

5 IT IS FURTHER ORDERED that the parties shall also set aside **January 25, 26, 27, 30, 31,**
6 **February 1, 2, and 3, 2006, for additional days of hearing**, if necessary, and subject to further
7 Order.

8 IT IS FURTHER ORDERED that the parties to the proceeding shall follow the procedure
9 outlined above to verify whether the proceeding will recommence on January 25 or 26, 2006.

10 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
11 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
12 hearing.
