RE: IN THE MATTER OF THE APPLICATION OF VOLO COMMUNICATIONS OF ARIZONA, INC. FOR CANCELLATION OF THEIR CERTIFICATES OF CONVENIENCE AND NECESSITY GRANTED PER DECISION 66940 (RESOLD LOCAL EXCHANGE, FACILITIES-BASED LONG DISTANCE, & FACILITIES-BASED LOCAL EXCHANGE TELECOMMUNICATIONS SERVICES) (DOCKET NO. T-04220A-05-0538)

On July 27, 2005, Volo Communications of Arizona, Inc. ("Volo") filed an application to cancel its Certificates of Convenience and Necessity ("CC&N") for Resold Local Exchange, Facilities-Based Long Distance and Facilities-Based Local Exchange Telecommunications in Maricopa County of Arizona. Volo's CC&Ns were granted by the Commission in Decision No. 66940 on April 21, 2004.

In its application and subsequent data request responses to Staff, Volo states that it:

- has never provided telecommunications service as authorized by Decision No. 66940,
- has never collected advances, deposits or prepayments,
- has never posted an operating bond
- has never had any telecommunications customers,
- does not currently have any customers, and
- has zero customers to notify or transfer.

Additionally, Volo has provided Staff with an affidavit of publication confirming the publication of legal notice of the application in all of the counties affected by this application.

Staff recommends approval of Volo's request for cancellation of its CC&Ns.
