MOTION FOR LEAVE TO INTERVENE

Pursuant to Rule 14-3-105, Arizona Administrative Code, Qwest Corporation ("Qwest"), applies to this Commission for an order granting leave to intervene in the above-captioned proceeding.

The Commission should grant Qwest leave to intervene in this matter because Qwest is directly and substantially affected by these proceedings. Dynamic Telcom Engineering I, LLC ("Dynamic") is seeking a Certificate of Convenience and Necessity to provide facilities-based and resold local exchange and interexchange telecommunications services within the State of Arizona. For many years, Qwest exclusively provided these services within the State of Arizona. As a result, Dynamic will be required to interconnect with Qwest, and the two telecommunications companies will have to provide services to each other if the Certificate is granted. Under these circumstances, Qwest clearly has a substantial and direct interest in the outcome of Dynamic's application.

Further, Qwest's participation in the proceeding will not unduly broaden the issues raised. The name, address and telephone
