PROCEDURAL ORDER

13 **BY THE COMMISSION:**

14 On June 4, 2001, Qwest Communications Corporation ("Qwest") filed with the Arizona
15 Corporation Commission ("Commission") an application for approval of transfer of Certificates of
16 Convenience and Necessity in association with internal corporate restructuring.

17 IT IS THEREFORE ORDERED that the hearing in the above-captioned matter shall
18 commence on **October 18, 2001, at 10:00 a.m.** or as soon thereafter as is practical, at the
19 Commission's offices, 1200 West Washington Street, Phoenix, Arizona 85007.

20 IT IS FURTHER ORDERED that intervention shall be in accordance with A.A.C. R14-3-105,
21 except that all motions to intervene should be filed on or before October 17, 2001.

22 IT IS FURTHER ORDERED that the Company shall provide public notice of the hearing in
23 this matter, in the following form and style, with the heading in no less than 12 point bold type and
24 the body in no less than 10 point regular type:

**PUBLIC NOTICE OF HEARING ON THE
25 APPLICATION OF QWEST COMMUNICATIONS CORPORATION
26 AND CERTAIN OF ITS AFFILIATES FOR APPROVAL OF TRANSFER OF
27 CERTIFICATES OF CONVENIENCE AND NECESSITY IN ASSOCIATION WITH
28 INTERNAL CORPORATE RESTRUCTURING**

On June 4, 2001, Qwest Communications Corporation ("Company") filed an application with the Arizona Corporation Commission ("Commission") for approval of transfer of Certificates Convenience and Necessity in association with internal corporate restructuring. The application is available for inspection during regular business hours at the offices of the Commission in Phoenix, at 1200 West Washington Street, Phoenix, Arizona, and at the offices of the Company, [insert address].

The Commission will hold a hearing on this matter beginning October 18, 2001 at 10:00 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.

1 Public comment will be taken on the first day of the hearing.

2 The law provides for an open public hearing at which, under appropriate circumstances,
3 interested parties may intervene. Intervention shall be permitted to any person entitled by
4 law to intervene and having a direct and substantial interest in the matter. Persons
5 desiring to intervene should file a written motion to intervene with the Commission,
6 which motion should be sent to the Company or its counsel and to all parties of record,
7 and which, at the minimum, shall contain the following:

- 8 1. The name, address, and telephone number of the proposed intervenor and
9 of any party upon whom service of documents is to be made if different
10 than the intervenor.
- 11 2. A short statement of the proposed intervenor's interest in the proceeding
12 (e.g., a customer of the Company, a shareholder of the Company, etc.).
- 13 3. A statement certifying that a copy of the motion to intervene has been
14 mailed to the Company or its counsel and to all parties of record in the
15 case.

16 The granting of motions to intervene shall be governed by A.A.C. R14-3-105, except that
17 all motions to intervene should be filed on or before October 17, 2001. The granting of
18 intervention, among other things, entitles a party to present sworn evidence at hearing
19 and to cross-examine other witnesses. Failure to intervene will not preclude any potential
20 customer from appearing at the hearing and making a statement on such person's own
21 behalf. You will not, however, receive any further notice of the proceeding unless
22 requested by you.

23 The Commission does not discriminate on the basis of disability in admission to its public
24 meetings. Persons with a disability may request a reasonable accommodation such as a
25 sign language interpreter, as well as request this document in an alternative format, by
26 contacting Shelly Hood, ADA Coordinator, voice phone number 602/542-3931, E-mail
27 shood@cc.state.az.us. Requests should be made as early as possible to allow time to
28 arrange the accommodation.

IT IS FURTHER ORDERED that the Company shall cause the above notice to be published
at least once in a newspaper of general circulation in its service territory, with publication to be
completed by October 7, 2001.

IT IS FURTHER ORDERED that the Company shall file certification of publication of notice
as soon as practicable, but not later than October 18, 2001.

IT IS FURTHER ORDERED that notice shall be deemed complete upon publication of same,
notwithstanding the failure of an individual customer to read or receive the notice.

IT IS FURTHER ORDERED that Staff shall file its Staff Report in this matter by October 9,
2001.

IT IS FURTHER ORDERED that the time periods specified herein shall not be extended
pursuant to Rule 6(a) or (e) of the Rules of Civil Procedure.

1 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
2 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
