**BY THE COMMISSION:**

On December 28, 2001, the Commission issued Decision No. 64286 which set new rates and charges for Bradshaw Water Company ("Bradshaw").

On January 7, 2002, Bradshaw filed a letter that, among other things, questioned one of the findings of fact in Decision No. 64286<sup>1</sup>. Specifically, Bradshaw pointed out a typographical error. Staff concurred with Bradshaw and requested that the number "24" be replaced with the number "30" on Page 8, line 13 of the Decision. The same error occurred on Page 6, Line 21. Therefore, the number "24" at Page 6, Line 21 should be replaced with the number "30."

IT IS THEREFORE ORDERED that Decision No. 64286 is amended at Page 8, Line 13, deleting the number "24" and inserting the number "30" in its place.

IT IS FURTHER ORDERED that Decision No. 64286 is amended at Page 6, Line 21, deleting the number "24" and inserting the number "30" in its place.


