PROCEDURAL ORDER

BY THE COMMISSION:

On December 28, 2001, in Decision No. 64287, the Commission granted authority to Dolan Springs Water Company, Inc. ("Dolan Springs") to sell its assets and transfer its Certificate of Convenience and Necessity ("CC&N") to Mount Tipton Water Company ("Mt. Tipton"). Decision No. 64287 also granted Mt. Tipton authority to take a loan from the Water Infrastructure Financing Authority ("WIFA") in the amount of \$880,000 in order to purchase the water utility assets of Dolan Springs.

Decision No. 64287 required that if Mt. Tipton was not converted to a water improvement district by December 31, 2002, it was to file a full rate case no later than April 3, 2002, utilizing a test year ending December 31, 2002, including 12 months of historical data from the combined companies.

On April 21, 2003, Mt. Tipton filed a request for an extension of time to May 15, 2003 to file the rate case as required by Decision No. 64287.

On May 1, 2003, the Commission's Utilities Division Staff filed a memorandum regarding Mount Tipton's request. Staff stated that the improvement district has not been completed and that compliance was due April 3, 2003. Staff has no objections to the request and recommends approval.

1 Mt. Tipton's request and Staff's recommendation are reasonable and should be adopted.

2 IT IS THEREFORE ORDERED that Mount Tipton Water Company, Inc. is hereby
3 authorized an extension of time until May 15, 2003, for the filing of the full rate case required by
4 Commission Decision No. 64287.
