In Decision No. 64287, Mount Tipton Water Company, Inc. (Company) was ordered to file a full rate case no later than April 3, 2003, utilizing a test year ending December 31, 2002 if it had not previously been converted to an improvement district by December 31, 2002. The improvement district has not been completed and compliance was due April 3, 2003.

On April 21, 2003, the Company filed a request for extension of time to comply stating that the accountant it has hired is continuing to work on its preparation. The Company is requesting an extension of time to May 15, 2003 to file the rate application. Staff has no objections and recommends approval.




