

MOTION TO CONSOLIDATE

Staff for the Utilities Division of the Arizona Corporation Commission, through undersigned counsel, hereby requests that the above-captioned Application for transfer of certificate of convenience and necessity ("CC&N"), W-02105A-01-0557 and W-01977A-01-0557, and the above-captioned Application for approval of financing, W-02105A-01-0556 be consolidated. Mount Tipton Water Company Incorporated ("Mount Tipton") will be acquiring Dolan Spring Water Company Incorporated's ("Dolan Springs") water utility assets and the operation of the water system in the area where Dolan Springs was previously given a CC&N. Mount Tipton's financing request is directly related to the acquisition of Dolan Springs. Both applications involve substantially similar issues that justify consolidation under Arizona Administrative Code R14-3-108(H). Such consolidation would not prejudice the applicant or any other parties.

1 In addition, since approval of Mount Tipton's financing application and CC&N transfer is
2 vital to its taking control of the utility operation of Dolan Springs, Staff would request that the
3 hearing dates be accelerated to an earlier date.
