



**PUBLIC NOTICE OF AN APPLICATION FOR AN ORDER AUTHORIZING THE ISSUANCE OF REVENUE BONDS AND REFUNDING REVENUE BONDS BY SALT RIVER PROJECT**  
Salt River Project Agricultural Improvement and Power District ("Salt River Project") has filed an application with the Arizona Corporation Commission ("Commission") for an order authorizing Salt River Project to issue \$675,000,000 of revenue bonds and \$730,000,000 of refunding revenue bonds ("Application"). The Application is available for inspection during regular business hours at the offices of the Commission in Phoenix, Arizona, and at Salt River Project's offices in Tempe, Arizona.  
Intervention in the Commission's proceedings on the Application shall be permitted to any person entitled by law to intervene and having a direct substantial interest in this matter. Persons desiring to intervene must file a Motion to Intervene with the Commission, which must be served upon Salt River Project and which, at a minimum, shall contain the following information:  
1. The name, address, and telephone number of the proposed intervenor, and any person upon whom service of documents is to be made if different than the intervenor.  
2. A short statement of the proposed intervenor's interest in the proceeding.  
3. Whether the proposed intervenor desires a prima facie evidentiary hearing on the Application and the reasons for such a hearing.  
4. A statement certifying that a copy of the Motion to Intervene has been mailed to Salt River Project.  
The granting of Motions to Intervene shall be governed by A.A.C. R14-2-105, except that all Motions to Intervene must be filed on or before the 15th day after this notice.
