**STIPULATION RE:  
PUBLICATION AND  
INTERVENTION**

9 On January 5, 2005, Litchfield Park Service Company ("Litchfield" or the "Company")  
10 filed an application for an extension of its Certificate of Convenience and Necessity to provide  
11 public wastewater utility service to various parts of Maricopa County, Arizona. The Procedural  
12 Order issued in that Docket required the Company to publish notice of the Hearing by February  
13 1, 2006, and further permitted Motions to Intervene in the proceeding to be filed before February  
14 14, 2006. The Company inadvertently failed to meet the required publication date, but can  
15 complete publication by February 7, 2006, including the new intervention date.


16 The Staff and Company have, with the Presiding Administrative Law Judge's  
17 concurrence, stipulated to revising the publication date to February 7, 2006 and permitting  
18 Motions to Intervene to be filed until February 21, 2006. The Applicant waives any written
