**PROCEDURAL ORDER**

**BY THE COMMISSION:**

12 On May 5, 2005, the Arizona Corporation Commission ("Commission") issued Decision No.  
13 67826 which approved the application of Arizona Water Company ("AWC") for an extension of its  
14 Certificate of Convenience and Necessity ("Certificate") to provide public water utility service to  
15 various parts of Casa Grande, Pinal County, Arizona. As a condition of the Commission's approval,  
16 the Company was to file, within 365 days of the effective date of the Decision, with the  
17 Commission's Docket Control, a copy of the developer's Certificate of Assured Water Supply  
18 ("CAWS") which is to be issued by the Arizona Department of Water Resources.

19 On February 3, 2006, AWC filed what was captioned "Motion to Extend Time to Comply  
20 with Filing Requirement/Certificate of Compliance" ("Motion") stating that it needs an additional  
21 365 days, until May 5, 2007, in which to file a copy of the developer's CAWS.

22 IT IS THEREFORE ORDERED that Staff shall file, by no later than February 17, 2006, a  
23 Response to AWC's Motion.

24 IT IS FURTHER ORDERED that the presiding Administrative Law Judge may rescind, alter,  
25 amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by  
26 ruling at hearing.


