Dear Judge Rodda:

First, I want to thank you for sending me information on intervention.

With everything in front of me I still made some mistakes. Your December 9th letter told me to phone 628-6550 if I had questions. On January 12th I phoned and had a good talk with Reg Lopez who told me that if I brought my original and ten copies to Suite 218 that he would distribute them as required. On January 25th I took 11 copies to Suite 218 and asked to see Reg Lopez. He came in, and said that I was to give the copie to the lady at the front desk, which I did.

I forgot to tell her that on my G-5 exhibits some were marked on the INDEX as Full, or Short, in ink, so I was glad that the next day Nanisha from Docket Control phoned that I did not have the Docket numbers on my front sheet, which was my INDEX. She said she would fix it by either writing Docket numbers on the INDEX, or placing my 8 page letter (which had all three Docket numbers in bold print) in front. So I thought everything was going fine.

When we came home on the evening of January 31st there was a message from Steve Gay, LQS Manager, on our phone that Larry Robertson, LQS Attorney, was greatly disturbed because I had not delivered a package of my exhibits to him, and he would be writing a letter to have me be removed as an intervenor. I phoned Steve Gay that I was taking my wife to see a doctor the next morning, but I would start photocopying the papers for Larry Robertson that afternoon. I went

to the Green Valley library yesterday afternoon and photocopied four sets, and last night I seperated them and stapled as required.


Late yesterday afternoon Steve Gay said that I believe Larry Robertson said that Jason Gellman was unhappy and Steve gave me Jason's phone number and I should phone very soon. I phoned this morning and Debbie Amal was very nice, and after lunch today she phoned back that all was o.k. and Jason had a copy of my exhibits on his desk.

I held up delivering my copies to Steve Gay and Larry Robertson this morning until I heard from Debbie Amal, because I thought I might have to rob the G-5 exhibit (my Miller Brooks plans booklet 1/3 to 1/2 inch thick) from Steve's or Larry's to send post haste to Jason. Now that Debbie says Jason has his copy I have delivered Steve's to the LQS office and I mailed Larry's this afternoon to P.O. Box 1448, Tubac 85646.

Copying of the G-5 Miller Brooks report I ordered several weeks ago from a commercial printer and I only ordered 12 copies and 6 copies marked "Short" do not have the last 25 or 30 pages in the booklet which are advertising of pumps, Bag Filter Vessels, etc. I still spent over \$300 to have these 12 copies made.

In your instructions to me on **INTERVENTION** it states, "Persons desiring to intervene must file a written Motion to intervene with the Arizona Corporation Commission (original and ten copies) which Motion must also be served upon the Company **or** its counsel,....." That is where I went wrong, I thought that one of the 11 would go to the company **or** its counsel. I am sorry I made an error and hope this clears everything up.
