14 FINDINGS OF FACT

15 1. On October 15, 2001, Qwest Corporation ("Qwest") filed an Application for
16 approval of an Amendment to the Interconnection Agreement between Qwest and Eschelon
17 Telecom of Arizona, Inc. f/k/a Advanced Telecommunications, Inc. ("Eschelon"). The original
18 Interconnection Agreement was approved by the Commission on April 28, 2000, in Decision No.
19 62489.

20 2. The Telecommunications Act of 1996 ("1996 Act") directed incumbent local
21 exchange carriers to make their networks available for Interconnection and Resale by new
22 entrants to the local exchange market. The 1996 Act provides for interconnection and resale
23 agreements to be concluded by voluntary negotiation.

24 3. This Amendment to the Interconnection Agreement between Qwest and Eschelon
25 was voluntarily negotiated, without resort to arbitration.

26 4. Under the terms of this Amendment, terms and conditions for Bill and Keep
27 language is added.





ORDER


