Information specific only to Nevada and/or California customers should be removed from the back of Arizona customer bills. Furthermore, the back of Arizona customer bills should contain explanations for two billing line items 'Base Tariff Rate' and 'Rate Adjustment.'

39. We also agree with Staff that anytime Southwest Gas initiates participation in a new natural gas docket at the FERC which relates to its service in Arizona, the Company should be required to provide Staff with a copy of Southwest Gas' initial filing in that FERC docket."
