On March 28, 2006, Arizona Water Company ("AWC") filed a motion requesting that the Arizona Corporation Commission vacate and reschedule the procedural conference set in this matter for April 3, 2006. Cornman Tweedy 560, LLC, ("Cornman Tweedy") does not oppose a short continuance of the procedural conference, but requests that the procedural conference be reset (subject to the Administrative Law Judge's availability and the Hearing Division calendar) for later in the week of April 3, 2006. On January 31, 2006, Cornman Tweedy sent AWC its first set of data requests in this docket with a due date of February 10, 2006—more than six weeks ago. AWC has never provided answers to any of the data requests, and it is clear that AWC will not answer the data requests until the Commission issues an order requiring the company to respond. For this reason, it is imperative that the procedural conference be held at the earliest possible date, in order to prevent any further delays by AWC.




