PUBLIC NOTICE OF AN APPLICATION FOR AN EXTENSION OF A CERTIFICATE OF CONFORMANCE AND NECESSITY BY ARIZONA-AMERICAN WATER COMPANY
Arizona-American Water Company ("Arizona-American") has filed with the Arizona Corporation Commission ("Commission") applications for authority for extension of its Certificates of Conformance and Necessity to provide water and sewer service to a contiguous area to its Anthem systems to serve the Arroyo Vista subdivision in a portion of the north half of section 10, Township 6 North, Range 2 East, Gila & Salt River Basins, Maricopa County, Arizona.
If the application is granted, Arizona-American would be the exclusive provider of water and sewer service to the proposed area. Arizona-American will be required by the Commission to provide this service under the rates and charges and terms and conditions established by the Commission. Arizona-American would not necessarily be required to provide service to these areas if the applicant owns their property. The application is available for inspection during regular business hours at the offices of the Commission in Phoenix at 1225 West Washington Street, and at Arizona-American at 19280 North Seventh Street, Suite 201, Phoenix, Arizona.
The Commission will hold a hearing on this matter. As a property owner, or customer, you may be entitled to participate in the proceeding. If you do not want to participate, you may appear at the hearing and make a statement on your own behalf.
