On October 26, 2005, AmeriVon LLC ("AmeriVon") filed an Application and Petition for Certificate of Convenience and Necessity to Provide Intrastate Telecommunications Services in the above-referenced matter. The application is not yet sufficient. This data request lists the information Staff needs to complete its analysis of your application. Please treat this, as Staff's Third set of data requests to AmeriVon in the above-referenced matter.

Answers or documents supplied in response to these data requests should be supplemented with any additional information or documents that come to your attention after you have provided your initial responses.

Please provide Docket Control with the information being requested within 60 days of the date of this letter. Mail an original plus 13 copies to Docket Control, Arizona Corporation Commission, 1200 West Washington Street, Phoenix, Arizona 85007-2927. If no response is received or all deficiencies are not remedied within 60 days, Staff will recommend that the application be terminated as per Rule R14-2-1103(B)3 and R14-2-510(E)3. If the application is terminated, the Applicant cannot provide the same telecommunications services in Arizona for which it is currently applying, until such time as a new application is filed with and approved by the Commission.

STF 3.2 Please provide the number of "contract" AmeriVon employees and their associated years of telecommunications experience in the following categories:

- 1 - Executive & Management
- 2 - Sales & Marketing
- 3 - Operations
- 4 - Information Technology

STF 3.3 If AmeriVon has initiated Resold Long Distance service in Arizona or any State, please provide the corresponding date(s) when service was initiated.

STF 3.4 Staff emphasizes the need to submit the affidavit required by (A-19) in the CC&N application filed by AmeriVon:

"For Resellers, the Applicant must complete and submit an affidavit of Publication Form as Attachment "C" before Staff prepares and issues its report."

STF 3.5 Staff clarifies that the Certificate of Good Standing requested in STF 1.10 has not been received as of the date of this data request.

STF 3.6 In response to STF 1.3 and STF 1.4, AmeriVon explained that it does not require nor collect deposits or advance payments. Staff emphasizes the need for AmeriVon to state its policy within AmeriVon's official tariff.
