FOURTH  
PROCEDURAL ORDER

**BY THE COMMISSION:**

On August 9, 2005, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity of Hearing ("Notice") against Brixon Group Ltd. ("Brixon"), Joseph Wayne and Jane Doe McCool, Donald John and Jane Doe Manning, Cameron Guy and Nanette Campbell (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of investment contracts.

Respondents, Cameron G. and Nanette Campbell, were duly served with a copy of the Notice.

On August 23, 2005, a request for hearing was filed for the Campbell Respondents.

On September 1, 2005, by Procedural Order, a pre-hearing conference was scheduled on October 5, 2005.

1 On September 8, 2005, the Campbell Respondents filed their Answers to the Notice.

2 On October 5, 2005, the Division and Campbell Respondents appeared through counsel.

3 During a brief recess, the parties discussed resolution of the issues raised in the Notice.

4 Subsequently, the parties requested a pre-hearing be scheduled on October 26, 2005.

5 On October 6, 2005, by Procedural Order, a pre-hearing conference was scheduled for  
6 October 26, 2005.

7 On October 26, 2005, the Division and the Campbell Respondents appeared through counsel.  
8 The parties requested that a hearing be scheduled.

9 On October 27, 2005, by Procedural Order, a hearing was scheduled for February 6, 2006.

10 On January 19, 2006, the Division and the Campbell Respondents filed a Stipulated Motion  
11 for Continuance ("Motion") to continue the above-captioned proceeding and to hold in abeyance the  
12 exchange of witness lists and copies of exhibits. The parties further requested that a pre-hearing  
13 conference be scheduled in June 2006 to discuss the status of the proceeding and any parallel  
14 proceedings.

15 On January 20, 2006, by Procedural Order, the Motion was granted continuing the hearing  
16 and a pre-hearing scheduled on June 21, 2006.

17 On March 2, 2006, counsel of record for the Campbell Respondents filed a Motion to  
18 Withdraw with notice provided to the Division and the Campbell Respondents. Counsel also  
19 provided a copy of the Third Procedural Order which scheduled the pre-hearing for June 21, 2006, to  
20 the Campbell Respondents. No objections have been filed to the Motion to Withdraw.

21 Accordingly, the Motion to Withdraw should be granted and the pre-hearing should take place  
22 as previously scheduled.

23 IT IS THEREFORE ORDERED that the Motion to Withdraw by Counsel for the Campbell  
24 Respondents is hereby granted.


