PROCEDURAL ORDER

BY THE COMMISSION:

On August 27, 1998, Network International, LC dba NIL LLC ("Applicant") filed with Docket Control of the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide competitive intrastate toll telecommunications services as a reseller within the State of Arizona. On February 11, 2000, Applicant filed an amended application. On July 25, 2000, Applicant filed Affidavits of Publication indicating compliance with Commission publication requirements. On August 18, 2000, the Commission's Utilities Division Staff ("Staff") filed its Staff Report in this matter.

On April 19, 2001, Applicant filed a letter indicating that it is no longer in need of a Certificate and is not providing service to customers in Arizona. Staff does not oppose the request. Under the circumstances, dismissal of the application is appropriate.

IT IS THEREFORE ORDERED that the Application of Network International, LC dba NIL LLC for a Certificate to provide resold telecommunications services shall be dismissed and the file administratively closed.


