**PROCEDURAL ORDER FOR
ADMINISTRATIVE CLOSURE**

BY THE COMMISSION:

10 On May 7, 2001, Qwest Corporation ("Qwest") filed tariff revisions to introduce five new rate
11 elements in the Common Channel Signaling Access Capability ("CCSAC") section of the Access
12 Service Tariff - ISUP and TCAP Signal Transport, and ISUP and TCAP Signal Switching. These
13 new rate elements would apply to carriers that interface with Qwest's signaling network. The access
14 services used by interexchange carriers are included in Basket 2 of the Price Cap Plan approved by
15 the Commission in Decision No. 63487.

16 On June 5, 2001, the Commission, in Decision No. 63745, suspended the tariff until
17 September 3, 2001, to allow Staff to complete its review of the filing.

18 On August 30, 2001, the Commission, in Decision No. 63978, suspended the tariff for an
19 additional 180 days, in order to allow Staff to continue its review of the application and to allow time
20 for Qwest and a third-party SS7 provider to reach a resolution of the issues raised in the filing. The
21 Commission also ordered the Hearing Division to set this matter for hearing.

22 This matter was originally scheduled for hearing to commence on January 3, 2002. The
23 hearing was subsequently rescheduled for hearing starting January 17, 2002. A procedural
24 conference was conducted on January 7, 2002.

25 On January 9, 2002, Qwest filed a Notice of Voluntary Withdrawal of Tariff. Qwest stated
26 that it had notified all intervenors and Staff of its intended withdrawal of the tariff application and
27 that no party objected to the withdrawal.

1 IT IS THEREFORE ORDERED that the hearing scheduled for January 17 and 18, 2002 shall
2 be vacated and that this docket shall be administratively closed, without prejudice to the applicant.


