COX ARIZONA TELCOM'S RESPONSE TO
QWEST'S MOTION FOR AMENDMENT OF PROCEDURAL ORDER

Cox Arizona Telcom, LLC ("Cox") hereby responds to Qwest's motion for amendment and requests that the Commission amend its October 10, 2001 procedural order.

Cox agrees with Qwest that the Commission should set a schedule for the filing of testimony in this docket. However, given that this is now a contested proceeding where witnesses will appear to testify, Cox requests that the hearing be moved to January 10, 2002 (from January 3, 2002) so that witnesses will not have to travel over the New Year's holiday weekend. Cox proposes the following schedule:

Qwest Direct Testimony	November 30, 2001
Intervenor/Staff Direct Testimony	December 19, 2001
Qwest Rebuttal	January 3, 2002
Hearing	January 10, 2002

Cox also requests a 24-hour discovery response time after the Qwest rebuttal is filed.

Cox believes that this schedule will not unduly interfere with the Commission's ability to meet the suspension deadline in this docket.
