14 On June 27, 2003, Voyager Water Company ("Voyager") filed a Request to
15 Modify or Amend Decision No. 64406¹ ("Request to Modify"), seeking to modify or
16 amend the Order included in Decision No. 64406, for the purpose of changing the type and
17 timing of compliance documentation to be subsequently obtained from the Arizona
18 Department of Water Resources ("ADWR") and from the Arizona Department of
19 Environmental Quality ("ADEQ").

20 On August 18, 2003, the Utilities Division Staff ("Staff") of the Arizona
21 Corporation Commission ("ACC") issued a Response to the Request to Modify stating that
22 "Staff has no objection to Voyager's request."

23 Voyager and Staff have since conferred and herein stipulate and agree to a
24 hearing on Voyager's Request to Modify at which Voyager will provide evidence


1 substantiating its Request to Modify to establish that Voyager is a fit and proper entity,


