

Transmitted herewith on behalf of VarTec Telecom, Inc., VarTec Telecom Holding Company, Teleglobe Holdings (U.S.) Corporation, Excel Telecommunications, Inc., eMeritus Communications, Inc., and Long Distance Wholesale Club, Inc. (collectively, the "Joint Applicants") are an original and ten (10) copies of this letter amending the above referenced application.

On November 2, 2001, the Joint Applicants filed the above-referenced application with the Arizona Corporation Commission ("Commission"). A Staff Report recommending the approval of the application without a hearing was filed on February 22, 2002, in the above-referenced dockets. However, during a review by the Hearing Division, two deficiencies were found in the application. Pursuant to a request by the Administrative Law Judge assigned to review this application, the Joint Applicants are correcting the deficiencies.

The Joint Applicants correct the following deficiencies:

- 1) On Page 3 of the application, in the second paragraph, the text should read "On May 22, 1996..." rather than "On November 14, 1995" and footnote 1 associated with this sentence should read "See Docket No. T-03188A-96-0302" rather than "See Docket No. U-3188-96-302." This docket number was assigned to the application filed by eMeritus Communications, Inc. (f/k/a Dial & Save of Arizona, Inc. d/b/a Dial & Save and Teleglobe Business Solutions, Inc.) for a Certificate of Convenience and Necessity to provide competitive intrastate telecommunications services as a reseller.

- 2) On Page 4 of the application, footnote 2 should read "See Docket No. T-02584A-91-0016" rather than "See Docket No. U-2584-91-016." This docket number was assigned to the application filed by Excel Telecommunications, Inc. for a CC&N as a reseller in the State of Arizona.

Excel Telecommunications, Inc. and eMeritus Communications, Inc. are currently providing service in the State of Arizona.


Additionally the Joint Applicants make the following correction:

- 1) On Page 4 of the application, footnote 3 should read "See Docket No. T-03955A" rather than "See Docket No. U-3164-96-240." Long Distance WholeSale Club, Inc. is a regulated reseller of long distance services.
