OF AN APPLICATION FOR AN ORDER AUTHORIZING THE ISSUANCE OF DEBT BY NAVOPACHE ELECTRIC COOPERATIVE, INC.

Navopache Electric Cooperative, Inc. (Applicant) has filed an Application with the Arizona Corporation Commission (Commission) for an order authorizing Applicant to issue \$33,231,000.00 in debt to finance the construction and operation of electric facilities (Docket No. E-01787A-05-0719). 1. The name, address, and telephone number of the proposed intervenor and of any person upon whom service of documents is to be made if different than the intervenor.

2. A short statement of the proposed intervenor's interest in the proceeding.

3. Whether the proposed intervenor desires a formal evidentiary hearing on the application and the reasons for such a hearing.

4. A statement certifying that a copy of the motion to intervene has been mailed to Applicant.

The granting of motions to intervene shall be governed by A.A.C. R14-3-105, except that all motions to intervene must be filed on, or before, the 15th day after the date this notice is published.
