McLeodUSA Telecommunications Services, Inc. ("McLeodUSA") hereby transmits for filing an original and 13 copies of the following response to request 1 of the first set of Data Requests from the Arizona Corporation Commission staff member, Armando Fimbres. Please file stamp the extra copy and return it to me in the enclosed, self-addressed, stamped envelope.

McLeodUSA submitted a tariff revision (filed January 19, 2006, Docket No. T-3267A-06-0035) that, among other things, proposed an increase to the current and maximum rates for WireCare for business customers, Call Waiting for residential customers, and Caller ID, Name and Number for residential customers. The Data Request dated February 19, 2006, only listed the increased maximum for WireCare for business customers. McLeodUSA answers included responses for all three of the impacted features, including Call Waiting and Caller ID, Name and Number, though McLeodUSA did not have any impacted residential customers.


