("UNS") made payment for the facilities contained within the area to be transferred to UNS. The payment constituted the last condition to the transfer of the Certificate of Convenience and Necessity ("CC&N") encompassing the area described in Exhibit A attached to Decision No. 68178. Mohave retains the CC&N encompassing the area described in Exhibit B to Decision No. 68178. Mohave acknowledges its obligation to provide not less than 6 (six) months notice to the property owner(s) within the area described in Exhibit B to Decision No. 68178 prior to transferring this portion of its CC&N to UNS.


