RESPONSE: No bond is currently required for ACI under any Commission order.

2. **In Exhibit C of the application, Applicant provides the proposed notice of change in long distance service provider that the Applicant will use to notify customers of ACI's planned discontinuance of long distance service. If there are any changes or amendments to this notice, please provide a copy of the amended customer notification sent and indicate the date it was sent. If no notice is sent, please explain why.**

RESPONSE: A copy of the notice that is actually sent will be provided to the ACC.

3. **Please indicate if customer notice will also be provided in Spanish and provide a copy of that notice.**

RESPONSE: Alltel does not intend to send the notice in Spanish.

4. **Please indicate if there are any affiliates of the Applicant currently offering telecommunications service in Arizona.**

RESPONSE: Western Wireless and Alltel Communications, Inc. are currently affiliates of AHCSI. After the consummation of the transaction, Western Wireless will continue to be an affiliate of AHCSI.

5. **After publication occurs, please provide an affidavit of publication indicating that Applicant has published legal notice of the Application to cancel in all counties affected by the Application. Counties affected are those that the Applicant is certificated to provide service in. Refer to Arizona Administrative Code R14-2-1107(B).**

RESPONSE: ACI requests that the publication notice be waived in light of the direct mailing of the notice to affected customers. Direct mailing is much more effective notice than publication in the legal notice section of a newspaper. The Commission has granted such a waiver in previous discontinuance dockets.

6. **Applicant states in its application that the transfer of services to AHCSI will be beneficial to the customers of ACI. Please state in what ways the transfer would be beneficial to customers.**

RESPONSE: First, AHCSI will focus entirely on the wireline business and be part of a large wireline entity that dedicates its capital and resources on providing the services that wireline customers need, rather than being the smaller part of a wireless entity. That should result in better priced bundles of services and calling plans to customers. Second, ACI will focus on wireless services to the same benefit without having to attend to a wireline customer base.

7. **If already determined, please provide the new corporate name of AHCSI.**

RESPONSE: AHCSI has not yet adopted a new corporate name.

8. **Please provide an Arizona Certificate of Good Standing for AHCSI, when available.**


